Der **Bahnhof Buckower Chaussee** ist ein Berliner S-Bahnhof an der Berlin-Dresdner Eisenbahn. Im bahnamtlichen Betriebsstellenverzeichnis wird er unter dem Kürzel *BBCH* geführt.

Geschichte



Übergang vom westlichen Bahnsteig zum
Parkplatz

Am 15. Mai 1946 wurde in Berlin, wie von der amerikanischen Besatzungsmacht gefordert, der Haltepunkt Buckower Chaussee an der Dresdner Bahn östlich der Dorfaue Marienfelde eingerichtet. Dieser Haltepunkt blieb über viele Jahre ein Provisorium an der damals eingleisigen S-Bahn-Strecke. Erst mit dem zweigleisigen Ausbau zwischen Marienfelde und Lichtenrade Ende der 1980er Jahre erhielt die Station ihr charakteristisches Aussehen. Die beiden Seitenbahnsteige reichen nun bis zur namensgebenden Straße heran. Dort überspannt ein großer Torbogen die Bahnsteige und Gleise und macht auf den S-Bahnhof aufmerksam. Im Süden schließt eine Brücke den Bahnhof ab. Über diese Brücke ist der P+R-Platz ohne Querung

der Gleise erreichbar.

Kurz vor dem Bahnhof befinden sich noch zwei schienengleiche Bahnübergänge im Verlauf der Säntisstraße und im Verlauf der stark befahrenen Buckower Chaussee. Im Falle der Wiederherstellung der Dresdner Bahn wird der Bahnhof umfangreiche Änderungen erfahren.

Anbindung

Der S-Bahnhof wird von der Linie S2 der Berliner S-Bahn bedient. Es bestehen Umsteigemöglichkeiten zu den Omnibuslinien der Berliner Verkehrsbetriebe und der Regionalen Verkehrsgesellschaft Dahme-Spreewald.

0. PREAMBLE

The purpose of this License is to make a manual, textbook, or other functional and useful document "free" in the sense of freedom: to assure everyone the effective freedom to copy and redistribute it, with or without modifying it, either commercially or noncommercially.
